## Summary of Catahoula Poll Results – Feb. 19-25, 2025

Louisiana Wildlife Federation conducted an informal poll with the following introduction:

Do you have an opinion about the current status of Catahoula Lake's habitat and recreational use? LWF wants to hear it! Please take our informal poll.

In 2020, the Louisiana Supreme Court upheld a trial court's decision in the case *Crooks v. State of Louisiana* that Catahoula Lake is not a lake but instead a river under Louisiana law. As a river under Louisiana law, the vast majority of waterbody is privately owned "riverbank" between the ordinary high and ordinary low water marks. In this way, a public lake of about 23,000 acres was largely privatized and many of the elements of public management have been put on hold or lost while various new landowners, both private and public, assert their new property boundaries.

Do you have an opinion or knowledge about Catahoula Lake and want to share it? If Yes, please continue with this poll. If No, thank you for your interest in wildlife and enjoying the outdoors.

## **Overview**

- The poll ran from Wednesday, February 19, 2025 through Tuesday, February, 25, 2025.
- The poll was sent to 10,937 members and 120 interested parties.
- We received 257 responses from 22 parishes, Wilkinson County, MS, and several out of state landowners, including:
  - 96 responses from Rapides
  - 43 responses from LaSalle
  - 10 responses from Catahoula
  - o 12 responses from Grant
  - 6 responses from Avoyelles
- Age of respondents

- 7. If you are a local resident or regular visitor to Catahoula Lake, what have you observed about the current condition of Catahoula Lake and want to comment about (Short Answer)
  - a. How could the LDWF throw away a reserve on the south end of the lake that was donated many years ago by a family to remain a refuge for ever. The so called land owners (land grabbers) remind me of the when the old west was settled. The first ones to claim and place their survey stakes becomes the owner. Berry and Crooks are prime examples of the bullying that is going on on the beautiful Catahoula Lake. The renaming of this beautiful paradise by some judge that had never set foot on this place is absurd.
  - **b.** There's not enough of fresh water entering from the north end of the lake . The vegetation growth has encroached on the open area of the lake. Certain aquatic vegetation has become a nuisance to the food availability for waterfowl. Oil pipes or placed directly on the bottom of the lake and are leaking petroleum into the water.
  - **c.** The boundaries and not fair and the "land owners" are claiming they already own it.
  - **d.** No refuge, no ducks!
  - e. Water level is so inconsistent and has a major role on duck hunting
  - **f.** If we continue to loose public access to places our kids won't get to experience the greatness of the outdoors!
  - g. The duck population here has gotten worse year after year. In the last 2 years without having the refuge in place, ducks found out there is no place to feed or rest. Hardly any ducks stay here anymore. Just passing through. I've been hunting here since 1980. Haven't seen it worse. Hunters spend millions of dollars here, but nothing to show for it. Ducks Unlimited and Delta Waterfowl spend lots farther north and in Canada ,yet the population is declining.
  - h. Catahoula has been ruined by the modified exhausts, constant boats running, people setting up within 300 yards of another party, no rest area for ducks, & the lake needs to be non accessible after 12pm, also guiding should be illegal on public land.
  - i. Needs to be managed to get the best habitat for the lake
  - **j.** Too much pressure all day

- **k.** Not the sportsman paradise it once was
- I. I've been hunting Catahoula lake for over 50 years started with my father use to be Duck paradise especially for Pintails and Mallards and all types of puddle ducks the ducks had the refuge to rest in when season opened and it would be stacked with puddle ducks during the season now they have no place to settle down and rest. Bottom line the refuge would hold 300000-5000000 ducks now it's nothing but open and blinds where ducks use to rest and bunch up. Really So sad for the ducks. Duck hunting is pitiful out there now only diving ducks. Please try to get the refuge back for the ducks!
- m. Catahoula Lake is not the habiatat it once was. Woody vegetation growth has reduced the natural open areas of the lake and prevents growth of natural grasses like chufa grass. The lawsuit granting ownership is an insult to the sportsman who have hunted and fished the lake for generations. The judge who ruled on the case was biased.
- Not having a large refuge for waterfowl to stay will hurt all hunters in Louisiana.
  Waterfowl will not stop anymore. What has been done to the lake affects all of Louisiana.
- **o.** Full public access needs to be restored. Outlaw permanent blinds on the entire lake. Stop all hunting and scouting after 2 p.m.
- **p.** its stinks.
- q. My family has hunted, fished and foraged this area for well over one hundred and 50 years. The current condition of this lake does not even closely resemble what it was 50 years ago. Under the mangement of the LDWF, the Lake has lost better than 40% of its available food production due to woody encroachment. Sedimentation has altered the drainage in such a way that it cannot be drained to maximize moist soil food production for waterfowl.
- r. Woody vegetation taking over
- **s.** The wooded encroachment is steadily spreading and moist soil habitat is depleting.
- t. Serious decline in ducks and ate a lot of boat traffic
- **u.** When the water gets high and kills all of the food the ducks aren't coming there to feed they are roosting from right after shooting light until the break of daylight and they are getting up and flying outta there.

- **v.** Guide services and mid motors are the problem. Guide services think they own the lake which is "public". No boundaries for private owned or leased property.
- w. Ducks can't rest anywer
- **x.** Lack of a refuge and over abundance of surface drive motors has contributed to the lake's decline.
- y. People claiming land that is a lake
- z. It's in good condition and it should be left alone no wma or private land
- aa. This needs to be fixed right awayCatahoula lake has been considered a lake since 1806 when it was documented as lake Catahoula to president Jefferson. It was a navigable Waterway then and still is no matter what a paid off judge rules about it. Our lake has been stolen by money hungry, dirty louisiana politics. This cant morally stand
- **bb.** Woodie vegatation is taking over the lake and eliminating areas where aquatic vegatation used to grow reducing the amount of feed that used to grow also commercial hunting is taking over and limiting the available area that other hunters have to use and increasing pressure on the ducks .

People work hard to have a place to hunt and someone who is to lazy to pull their pants up can get in a blind that has been brushed and decoyed by a hard working person and have someone put in jail for wanting to hunt in his own blind spot. - **gg.** Enjoyed recreational activities on Catahoula since I was a small child to present day. All recreation activities have progressively gotten worse with each year that

passes. For my children's benefit, I would like to see all activities restored so they can experience this state treasure that I was able to enjoy.

- **hh.** The lake definitely needs the reserve back in the middle of the lake definitely hurt a lot of birds from having a spot to rest big decrease in birds seen daily on the lake
- ii. Need the refuge back
- **jj.** The commercialization of the lake with to many guide servicesThe duck numbers going down and the private vs federal land mess making it impossible to hunt and enjoy yourself.
- **kk.** Need to clear out the trees.
- **II.** This waterbody is too important to disregard and do away with the historical management practices that have been in effect for quite a while!
- **mm.** Its a shell od what it once was because of guide services and greed. Guiding should be banned amd the lake returned to what it once was
- **nn.** A muffler regulation on boats entering or exiting the lake. The boat ramps need to be updated.
- **oo.** It's the same as everywhere in Louisiana, the state government is allowing so called land owner's to claim public waters and use the crooked police and Louisiana courts to enforce their illegal activities, it's destroying the quality of life for people in Louisiana who love to fish. - **ss.** Ive been on Catahoula Lake personally for 30 years, following my dad and grand father. I also served on the Catahoula Lake Conservation Club board for many years. The hunters actually care about the lake. They want a safe place near home good hunting and fishing for their family. We need to get back to water level management which helps create food and habitat for waterfowl, fish, etc.

- **tt.** Loud shallow drive motors and people with no respect for others have ruined the Lake!!
- uu. I believe the current situation of catahoula lake and private land owners is completely asinine. Duck numbers have dropped off tremendously. I feel this stems from no refuge and hunters having access to the lake sunrise to sunset. I believe regulating hunting hours would improve the lake tremendously.
- vv. Less and less ducks every year
- **ww.** I don't understand how federally funded structures like the weir at the intersection of US hwy 84 and 28 and the Diversion Canal can be used to annually flood private land with no access to the public for hunting or fishing
- **xx.** We should be ashamed of what happened to the lake. It went from the largest natural duck habitat lake in North America to a mere shell of what it should be
- yy. Live local resident . Enjoyed Catahoula Lake for 40 years .
- zz. It's a fight waiting to happen. It needs to be better controlled
- **aaa.** Regardless if it partially goes private or if it goes public it needs to be resolved ASAP. From a law enforcement standpoint our hands are tied in many circumstances.
- **bbb.** It's not like it used to be!!
- **ccc.** I'm confused about how it will be managed as a lake again
- **ddd.** Water elms encroaching the lake bed is taking over areas of the lake
- **eee.** Harrasment from locals, decline in outsider hunting opportunities, decline in ease of access
- **fff.** My observation of Catahoula Lake has been disappointing. It has been handled to fullest legal extent and has only pleased a small amount of elect hunters while the majority of the lake have to suffer for small amounts scraps that LDWF has given permission to hunt . The entire made up survey was surveyed incorrectly and should be re surveyed and Catahoula Lake should be given back to the public. I am in favor of the no blinds so I hope if it did go back to that there there would be restrictions on it to help out with the Waterfowl.

ggg. WATER IS TOO LOW

- **hhh.** Very disappointed that a body of water with a public control structure doesn't have public access.
- **iii.** There is too many people on the wma and it is way too crowded during duck season. I believe it needs to be expanded
- **jjj.** The refuge needs to be re-established immediately it is severely important to wintering waterfowl.
- **kkk.** It has gotten really bad over the last 20 years. It's truly sad that the state of Louisiana would let what's been going on happen to what was once one of the best waterfowl hunting areas in North America. Truly sad that greed and laziness let this happen.
- **III.** The property is not a lake! Have you not been paying attention? When the boundary lines are approved by the court the individual land owners will have the right to do what they want to do with their own property. This is no longer available for public use!
- mmm. Waterfowl have no where to rest
- nnn. I visit Catahoula Lake at least twice a year to look for birds and butterflies.I hope that it continues to have public access rather than have houses built around the lake limiting access. Cross Lake in Shreveport has very little access.
- **ooo.** All of the people that used to hunt the lake are now all congested into the small portion that is Dewey wells and makes it hard to safely hunt due to not being able to get spaced away from other hunters.
- **ppp.** No refuge =no ducks
- **qqq.** Don't know where nothing is boundaries private or public and neither does the land owner or wildlife and fisheries
- **rrr.** Trees need to be cut for more grass to grow. Especially all of the worthless elm trees on the edges. Those areas are useless
- **sss.** The state has really let the public down on this whole situation, they just basically gave away the land that was given to them at time of statehood in 1812. The state of Louisiana did not own a single acre of land at time of statehood, EXCEPT all of water water bottoms within the state. Which includes Catahoula Lake. But we have all seen it happen, something that should have never been allowed to happen. The ONLY way this could and did happen, is the state not having an expert witness Professional Land Surveyor through this case. I can guarantee you

that if the state would have hired the expert witness Professional Land Surveyor that the Crooks' hired from the get go, this would have never happened. But guess what, the state never realized that they needed one to inform them and fight for them. It was only in early 2019 that the NSPS or LAPELS board really even knew anything about the case and what was happening. The National Society of Professional Surveyors were notified this was happening in January 2019, just 2 weeks before the final Supreme Court ruling to try and defend the Public Land Survey System that is used throughout most of the United States. This was not enough time to get all the details and documents together and analyze them. BUT they did put together a slide show, and stated that this decision is wrong and should not be accepted by the supreme court. Stating "The Public Land Survey System ("PLSS") was designed to eliminate confusion regarding title and land locations. The district court and Third Circuit based their decision on evidence which ignores the historic GLO plats that are the very foundation of a land ownership in the United States." Which was how the General Land Office surveyors surveyed the lake, by establishing township, ranges and sections around the lake, meander lines along the high water mark. Which are supposed to be held and WITHOUT ERROR. So now that the courts have ruled the lake as a navigable river "little river" running through what was called the lake and exiting at french fork, we now have a low water mark (24.08') and a high water mark (36'). By Louisiana law, the land in between is the banks of the river. If it is a lake, the boundaries are to the high water mark (36') and the original meander lines ran by the General Land Office surveyors at the time of first creation. So NOW here is the next big mess all of wrong doing is creating. Let's not forget our Louisiana Laws then regarding "Private things subject to public use" and "Banks of navigable rivers or streams". Louisiana Civil Code, Article 456, states: "The banks of navigable rivers or streams are private things that are subject to public use. The banks of a navigable river or stream is the land lying between the ordinary low and the ordinary high stage of the water. Nevertheless, when there is a levee in proximity to the water, established according to law, the levee shall form the bank." Louisiana Civil Code, Article 455, states: "Private things may be subject to public use in accordance with law or by dedication". So guess what we have now. A River that is very narrow within what was known as the lake, with really long banks. We are talking possibly a mile or more of a bank now in some places. Remember what use to be known as the edge of the lake or "the start other people's property" along the lake, well that is now the end of these long banks and the high water mark. Which by Louisiana Law and definition are the banks of Little River and are now privately owned, BUT subject to public use. So I find it very hard to believe trespassing laws can be upheld in the courts in the areas NOW known as the banks of the river. But hey, maybe nobody has thought about that one, just like not thinking about hiring an expert witness to fight for the State and what's right. I was born and raised in LaSalle Parish, been hunting this lake all my life. I've said for years, this could never happen. That catahoula lake has been a lake since the very beginning, no way judges would go against the very foundations the State of Louisiana was created on and most all other states. That

for sure, they had the best expert witness money could buy. But boy was I wrong, they never even knew they needed it.

- **ttt.** salt water encroachment, LNG expansion and environmental degradation,the death of Cameron, Holly Beach, Hackberry, etc.
- **uuu.** I'd like to see restricted hunting hours.
- **vvv.** Trash everywhere pitiful
- **www.** I'm a regular visitor. The hunting will be ruined if it's turned into a wma. The private land guys are the reason the hunting is so good there. Ducks feel safe coming to this lake
- **xxx.** Woody encroachment and habitat quality has declined markedly since LDWF was barred from management of now-private land. However public access is now better with the expansion of Dewey Wills WMA, and if USFWS would secure their portion of the lakebed, BOTH enhancing public access AND reestablishing the waterfowl refuge could be done. Whatever happens, it can NOT go back to the wide-open, unregulated, access controlled through squatting and intimidation that was the situation prior to the lawsuit.
- **yyy.** The lake is in decline you have no refuge for ducks. . The guides on the new ".private" run off what birds do show up . A small group of guides hunt the entire lake chasing what birds do show up. Ducks must have feed and a refuge on Catahoula LAKE. The recent changes have not only destroyed the lake but many lives and traditions surrounding the lake. Please do what is right. Remember in life for evil to flourish it only requires good men to do nothing. Don't be those good men who fail to act. Be men or women of character and do what's necessary.
