SUBJECT: EDUCATING THE LOUISIANA PUBLIC ON HUNTING-RELATED TRESPASS

<u>WHEREAS</u>, trespassing during hunts is a contentious issue every year in Louisiana as evidenced by annual squabbles in sportsmen's internet chat rooms such as LouisianaSportsman.com and BayouBucks.com; and

<u>WHEREAS</u>, the Louisiana Department of Wildlife and Fisheries (LDWF) generally oversees hunting in Louisiana and has an obligation to the public to manage its programs so that hunters can more easily comply with legal requirements; and

<u>WHEREAS</u>, most states educate their public regarding the legalities of trespassing by including information in their annual hunting regulations – for example:

- Texas "Under the trespass provisions of the Penal Code, a person on a property without the permission of the landowner is subject to arrest." (Regulations Summary, Texas Parks & Wildlife Outdoor Annual 2012 2013, pg 23),
- Oklahoma "Hunters must obtain permission to enter any posted or occupied land or land primarily devoted to farming, ranching, or forestry purposes."

- Arkansas "To hunt, fish, trap, or release hunting dogs on private property, hunters must have permission from the landowner or leaseholder."

- Mississippi "Landowner permission is required to hunt, fish, or trap on private lands."

- Alabama "It is illegal to hunt, trap, capture, injure, kill, or destroy any wild game on another person's land without having in possession the written permission of the landowner or person in control of such land, unless accompanied by the landowner or unless a guest of the landowner." (http://www.eregulations.com/alabama/hunting-regulations-info/ -- Alabama Hunting & Fishing Digest, 2012 2013 Requirements, Fees, & Season Dates Hunting Permission Requirement section); and

<u>WHEREAS</u>, LDWF has proposed to provide guidance in documents (such as the annual hunting regulations) commonly read by Louisiana sportsmen concerning trespassing.
